ORDINANCE NO. 11

AN ORDINANCE OF THE CITY OF UNIVERSITY PLACE, WASHINGTON, REQUIRING CITY OFFICIALS TO EXECUTE AN OATH OR AFFIRMATION; REQUIRING THE CITY MANAGER, ASSISTANT CITY MANAGER, AND CITY CLERK TO EXECUTE AND FILE A BOND IN FAVOR OF THE CITY; AND SETTING THE AMOUNT THEREOF.

WHEREAS, RCW 35A.12.080, 35A.13.070 and 35A.13.160 require the City Manager, Assistant City Manager, City Clerk, and such other officials and employees as may be designated by the City Council, to file a bond in favor of the City;

WHEREAS, RCW 35A.12.080 authorizes the City Council to require officers to take an oath of affirmation before entering upon their duties; NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF UNIVERSITY PLACE, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. Oath required. Before entering upon the performance of the duties of office, any City officer shall take an oath or affirmation, as set forth in attached Exhibit A to this Ordinance, for the faithful performance of the officer's duties. The oath or affirmation shall be filed with the Pierce County Department of Records and Elections.

Section 2. <u>Bond Required.</u> Prior to entering upon the performance of duties, the City Manager, Assistant City Manager, and the City Clerk shall be required to furnish an official bond, to be renewed annually, conditioned on the honest and faithful performance of their duties. The premium on the bond(s) shall be paid by the City. The amount of the bond(s) shall be:

City Manager \$50,000 Assistant City Manager \$50,000 City Clerk \$10,000

Section 3. <u>Effective Date</u>. This Ordinance shall take effect on the official date of incorporation.
