RESOLUTION NO. 67

A RESOLUTION OF THE CITY OF UNIVERSITY PLACE, WASHINGTON, AUTHORIZING CIRCULATION OF A 60% PETITION FOR ANNEXATION TO THE CITY OF UNIVERSITY PLACE BY RESIDENTS OF THE AREA COMMONLY KNOWN AS FIRCREST ACRES.

WHEREAS, the incorporation of the City of University Place (hereinafter University Place) on August 31, 1995 has resulted in certain small unincorporated areas remaining between University Place and other municipal jurisdictions; and

WHEREAS, the Comprehensive Plan and Map adopted by the Pierce County Council effective January 1, 1995, established Comprehensive Urban Growth Boundaries and indicated that, in cases of overlapping growth boundaries between some jurisdictions, the citizens could choose to which city they wanted to annex; and

WHEREAS, the City of Fircrest (hereinafter Fircrest) submitted a Notice of Intention to the Pierce County Boundary Review Board (BRB) in June, 1994 to annex the "Fircrest Acres" area, and the BRB passed a motion, on December 1994, approving the annexation proposal, subject to an affirmative vote of affected residents; and

WHEREAS, the City of Fircrest held an election on September 19, 1995 asking whether "Fircrest Acres" should be annexed to Fircrest, and the proposal was defeated; and

WHEREAS, on September 26, 1995, property owners desiring to annex to University Place through the 60% petition method provided written notice of their intent to annex and the initiating parties represent not less than 10% of the assessed value of the property for which annexation is sought (RCW 35A.14.120); and

WHEREAS, on November 6, 1995 the City Council of University Place met with the initiating parties and by unanimous motion agreed to accept the request and allow the annexation to proceed with the circulation of a petition, pursuant to RCW 35A.14.120; NOW THEREFORE,

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF UNIVERSITY PLACE, WASHINGTON, AS FOLLOWS.

Section 1. <u>Acceptance and Authorization to Circulate 60% Petition.</u> The City Council hereby accepts the proposed annexation of an area commonly referred to as Fircrest Acres, as legally described in Exhibit A and as shown on the map in Exhibit B to

this resolution, and authorizes circulation of the 60% petition pursuant to RCW 35A.14.120 and the rules for petitions in RCW 35.A.01.040.

- Simultaneous Adoption of Zoning. The simultaneous adoption of zoning comparable to the Fircrest Area's presently existing zoning designation will also be required.
- Section 3. Effective Date. This resolution shall take effect immediately upon signing.




FIRCREST ACRES AREA LEGAL DESCRIPTION OF PROPOSED ANNEXATION
