A RESOLUTION OF THE CITY OF UNIVERSITY PLACE, WASHINGTON, AUTHORIZING EXECUTION OF A CONTRACT FOR IMPROVEMENT SERVICES WITH LONE STAR NORTHWEST, INC.

# BE IT RESOLVED THE CITY COUNCIL OF THE CITY OF UNIVERSITY PLACE, WASHINGTON, AS FOLLOWS:

- Section 1. <u>Authorization</u>. City Manager or his designee is authorized and directed to execute on behalf of the City the Contract for Services with Lone Star Northwest, Inc. for improvements of Grandview Drive West and the area along said road.
- Section 2. <u>Ratification and Confirmation</u>. Any acts made consistent with the authority and prior to the effective date of this resolution are ratified and confirmed.
- Section 3. <u>Effective Date</u>. This resolution shall take effect immediately upon signing.

#### AGREEMENT BETWEEN CITY OF UNIVERSITY PLACE

#### AND LONE STAR NORTHWEST, INC.

This Agreement is entered into between the CITY OF UNIVERSITY PLACE, hereinafter "City", and LONE STAR NORTHWEST, INC., hereinafter "Lone Star";

WHEREAS, the City desires to improve Grandview Drive West and the area next to the road now owned by Pierce County in order to form a safer and more attractive area; and

WHEREAS, the City is considering its options for acquiring sufficient funds to improve the road and other related improvements; and

WHEREAS, Lone Star is desirous of assisting with such improvement, thereby providing to the City benefits to the public;

NOW, THEREFORE, it is hereby mutually agreed as follows:

- 1. Lone Star will furnish assistance to the City of University Place in an amount not to exceed Forty Thousand Dollars (\$40,000.00) for the City's improvement of Grandview Drive West and/or landscaping along said road and other improvements, including but not limited to the future relocation of the fence;
- 2. The City may and will utilize part or all said funds up to Forty Thousand Dollars (\$40,000.00) to provide the road and other related improvements for the benefit of its citizens; and
- 3. The City will be responsible for obtaining any necessary permits and approvals for the road improvements.
- 4. In the event that the City decides to raise revenue by the imposition of a tax affecting Lone Star or its affiliates, this Agreement shall be of no force or effect, and the amount of any contribution made by Lone Star will be refunded.
- 5. Each of the parties signing this Agreement is legally authorized to enter into the terms and conditions of this Agreement, and is authorized to legally bind such parties thereto.


