## A RESOLUTION OF THE CITY OF UNIVERSITY PLACE, WASHINGTON, AMENDING THE CITY FACILITY RENTAL RATES FOR CIRQUE PARK, SUNSET PARK AND THE CURRAN APPLE ORCHARD
